

## Important Information to Know Before Camp

We will be adhering to a Transmissible Disease Code of Conduct at Camp Mardi Gras, this code of conduct is at the bottom of this document.

Please be patient and understanding of others well at camp, we all will have different comfort levels while at camp, and we want everyone at camp to feel safe

### Pre-Screening

- Pre-screening will be done at the entrance to camp
- You must pass the pre-screening before you are allowed onto the site
- If you fail the pre-screening, you will be sent home at your own cost

### Patrols

- We will be enforcing Scouts Canada's policies regarding patrols for all campers.
- Scouts Canada requires all in-person activities to be split into **smaller teams (patrols) of 8 or fewer participants**.
- Patrols must remain separate and maintain a physical distance of 2 meters from other patrols
- Equipment may only be shared within a patrol and must be cleaned between each use. This means that each patrol must be able to cook for themselves and may not share food or equipment with other patrols.

### Tent Sharing

- Scouts Canada limits tent sharing to anyone within the same patrol. We recommend tent sharing only for people living in the same household.

### Physical Distancing

- Everyone must maintain a physical distance of 2 meters from each other.
- When it is impossible to maintain a physical distance of 2 meters from another person, a mask must be worn.

## **Transmissible Disease CODE OF CONDUCT**

*While participating in the Camp Mardi Gras, it is the expectation that all participants, leaders/Scouters, and staff will abide by the code of conduct set forth by the Camp Mardi Gras committee. While at the event all participants, leaders and staff will be conscientious of others' rights of participation, personal space, and acceptable risks. The following is a code of conduct that everyone agrees to upon registration of the event and consists of:*

1. Respect physical distancing of more than 2 meters where possible of all camp participants and staff.
2. Wear a non-medical facial covering when:
  - o Physical distancing is not practical including when in outdoor spaces. This includes but not limited to line ups, headquarters, buses, and camp activities
  - o in enclosed spaces or inside buildings.
3. No more than 5 guests from outside a site, can congregate in a designated campsite.
4. Observe physical distancing where possible when in individual campsites
5. Camp Sites must be at least 50 feet in separation from one another
6. The leader in-charge of any given group of participants must conduct a health screening before arriving at camp.
7. The leader in-charge of any given group of participants must conduct a daily health screening. This is to complete no later than 10:00am each morning and is attached to this document
8. In the event of a participant or leader presenting with one or more of the symptoms on the health screening form, they will immediately notify the Camp Safety Officer, isolate the participant and group, and await instruction from the Camp Safety Officer.
9. The participants, leaders and staff agree to notify the Camp Safety Officer in the event where a participant, leader or staff develop symptoms and tests positive for a transmissible disease up to 96 hours after the end of the event.

## Covid-19 Self Assessment

**1. Do you currently have one or more of the symptoms below that are new or worsening?**

Symptoms should not be chronic or related to other known causes or conditions.

- fever or chills
- cough or barking cough (croup)
- shortness of breath
- decrease or loss of smell or taste
- fatigue and/or malaise (for adults)
- nausea/vomiting, and/or diarrhea (for <18 years of age)

**2. Has a doctor, health care provider, or public health unit told you that you should currently be isolating (staying at home)?**

This can be because of an outbreak or contact tracing.

**3. Do you live with someone or have been in close contact with someone who has been told by a doctor, health care provider, or public health unit that they should currently be isolating or have tested positive for a transmissible disease.**
